2. Book Launch: The book "Capitalising on constraint: Bailout politics in Eurozone countries" by Catherine Moury, Stella Ladi, Daniel Cardoso and Angie Gago" now available in Greek

This book explores the constraints and opportunities of the adjustment programs in the five bailed out Eurozone countries, in the period during and beyond the crisis (2007-2019). It shows that bailed out governments had room for manoeuvre and, under certain circumstances, were able to exploit the constraint of conditionality to their own advantage. It additionally demonstrates that after a bail-out programme governments use their discretion to revert the measures which bring the greatest benefits at a lower cost.

1. 2023 ESRC Postdoctoral Fellowship competition

LISS DTP invites applications for seven ESRC-funded Post-Doctoral Fellowships

(PDFs) to commence from 1st October 2023 to be held at King's College London, Queen Mary University of London, or Imperial College London. These provide an opportunity for those in the immediate postdoctoral stage of their career to consolidate their PhD through developing publications, networks, and research and professional skills.

Fellowships will provide funding for up to one year full-time, or up to two years part-time to cover the fellow's salary plus up to £10,000 of additional costs (e.g. travel, conference attendance, training, fieldwork, mentoring time, etc.).
