## 1. <u>PSA 2024 Annual Conference - General Call for Papers on Greek</u> Politics

One of the core aims of the Greek Politics Specialist Group (GPSG) of the Political Studies Association (PSA) is to organise focused, scholarly panels at the annual conference of the PSA, featuring senior and junior academics and researchers working on Greek politics. The GPSG has a consistent and strong presence at PSA annual conferences, while also promoting collaborations with other Specialist Groups and international networks.

The 2024 Political Studies Association (PSA) Annual Conference will be hosted by the University of Strathclyde in Glasgow and will take place fully in-person from 25 – 27 March 2024. The theme of the conference is "After (Neo-) Liberalism: Towards an Alternative Paradigm?". For full details regarding all aspects of the Conference, please visit the PSA's website.

The GPSG cordially invites scholars to submit paper and panel proposals on all aspects of Greek society and politics. We wish to particularly encourage comparative, cross-disciplinary and collaborative proposals, as well as papers featuring original theoretical ideas and empirical data. Moreover, we particularly welcome submissions from junior scholars, and scholars from under-represented groups. All methodological and

epistemological approaches based on sound social science reasoning are welcome.

Please send your proposals for papers (consisting of a paper title, 200-word abstract, institutional affiliation and full contact details) or panels (with full details of the papers Convenors **Dimitris** and authors) to our Group Skleparis (dimitris.skleparis@newcastle.ac.uk) Vasiliki (Billy) Tsagkroni and (v.tsagkroni@fsw.leidenuniv.nl), who will be happy to respond to any enquiries about this call or the conference.

The **deadline** for submitting proposals is **Monday 6 November 2023**. Applicants will be notified whether they have been included in the GPSG's panels ahead of the final PSA deadline (before 6 November).

## 2. Call for Greek local elections commentary

Following the success of **its** previous <u>pamphlets</u> on **the Greek** national elections, the **Greek Politics Specialist Group (GPSG)** aims to publish another collection of comment pieces on local elections in Greece, reflecting the results of the polls on the 8th and 15th of October 2023.

The purpose is **to open the discussion around local elections in Greece**, a relatively under-researched topic, and start a conversation about their meaning, impact, and repercussions. Additional perspectives or viewpoints can also be the subject of a potential article, such as policy communication and campaigns. Pieces either on specific municipalities and regions or general comments are also welcome.

We invite opinion/analysis articles of **700-1000 words** in English, analyzing, interpreting, or reflecting on the process and the outcome of the Greek local elections in 2023.

The goal is to publish the articles on a special edition pamphlet. Please take into account the word limits and make sure that papers have been carefully proofread and require minimal editorial work. Please email your piece to Angelos Angelou (A.Angelou@lse.ac.uk) and George Dikaios (gdikaios@uoa.gr) by Monday, 8th of January, which is the final deadline, along with your full title and institutional affiliation.

#### 3. New research opportunity at the GPSG

The Greek Politics Specialist Group of the UK Political Studies Association (PSA) invites applications to conduct research on the topic "The Politics of Climate Resilience in Greece".

The recent catastrophic wildfire in Evros and the flood in Thessaly were stark reminders that Greece is one of the European countries most strongly experiencing the consequences of climate change. What have the political and socioeconomic consequences of such natural disasters been in Greece, and what can we learn from them about the likely effects of climate change on European politics more broadly? Through which political coalitions and policies can Greece build climate resilience, reinforcing its ability to mitigate the most negative effects of future natural disasters?

Researchers are invited to submit their research proposals (up to 500 words) in English related to the above theme. One project will be selected for an award of £250. The successful project will run for a period of up to 5 months leading to the publication of a GPSG Working Paper. The selected researcher will receive mentorship from a member of the GPSG Executive Committee, and they will be expected to join the GPSG and contribute to the Group's academic activities.

#### Qualifications:

- PhD candidates or a recent PhD degree in Social Sciences (Politics, Economics, Sociology)
- Excellent knowledge of English as a working language and good knowledge of Greek
- Experience in conducting research focusing on contemporary politics in Europe or another world region.

Duration of the contract: November 2023 – April 2024

## 6. GPSG Working Papers

The GPSG welcomes scholarly working papers, as well as preliminary or interim reports of ongoing research. There is no word limit, although we encourage prospective contributors to aim for a length of 3,000 – 4,000 words (research reports) and 4,000 – 8,000 words (full papers). All submitted papers go through peer-review, thus, receiving much constructive feedback that facilitates their future development. We strongly encourage PhD researchers and junior scholars to submit their work.
